“The Changing Face of Construction Disputes – War Stories”

David Bateson, King & Wood Mallesons

David Bateson will present his talk at the conclusion of the SCLHK Annual General Meeting at the Hong Kong Club, 3A Chater Road, Central, Hong Kong

David will talk about his experience in construction dispute resolution in Hong Kong and around Asia and how it has changed since his arrival in Hong Kong in 1980. He will tell many war stories.

David is a partner in the Hong Kong office of King & Wood Mallesons where he specialises in construction projects and dispute resolution. He is the founder of the firm's award winning Asian construction practice, which has won the ALB Construction Law Firm of the Year five times. David is a practising mediator and arbitrator, with extensive experience in over 70 arbitrations in Asia, the Middle East and Europe, mainly involving construction disputes, but also resources, joint ventures, shareholder agreements, telecommunications, banking and finance, investor/state, and shipping. He has acted as Chairman, party-appointed arbitrator, or sole arbitrator under the auspices of the HKIAC, SIAC, CIETAC, ICC, PCA, AAA and LCIA, or in ad hoc arbitrations. David is the author of the book *Commercial Arbitration in Hong Kong*, and contributed chapters to *Arbitration in Hong Kong: A Practical Guide*, *Arbitration World* (chapter "alternative dispute resolution"), and *Chitty on Contracts - Hong Kong Volume*.
