

## THE SOCIETY OF CONSTRUCTION LAW HONG KONG SCHOLARSHIP

### RULES

#### Name

1. The name of the scholarship shall be “The Society of Construction Law Hong Kong Scholarship”.

#### Interpretation

2. In these Rules, unless the context otherwise requires:

“Society” means Society of Construction Law Hong Kong;

“Council” means the Council of Society of Construction Law Hong Kong;

“Member” means a member of the Council;

“pupil” means a pupil under the Barristers (Qualification) Rules, Cap. 159E;

“pupillage” means an approved pupillage under the Barristers (Qualification) Rules, Cap. 159E with a practicing barrister whose practice is significantly in the area of construction law;

“Scholar” means the recipient of an award under the Scholarship;

“Scholarship” means the Society of Construction Law Hong Kong Scholarship;

“Scholarship Committee” means the special committee established under Rule 14 below.

A person is or has been “qualified for practice as a legal practitioner (of whatever description)” if he is or has at any time been admitted or otherwise recognized by the relevant authority in the jurisdiction concerned as a legal practitioner (of whatever description) and has completed all required training or apprenticeship (if any) and a person is so qualified notwithstanding the necessity to comply with any further administrative or financial requirements.

3. Unless the context otherwise requires, words importing the singular shall include the plural and vice versa and words importing the masculine gender shall include the feminine gender.

### **Object**

4. The object of the Scholarship is to encourage candidates of the highest calibre, who are not, and have not at any time been, qualified for practice as a legal practitioner (of whatever description) in any jurisdiction (including Hong Kong) and who are permanent residents of the Hong Kong Special Administrative Region, to undertake a pupillage with a practicing barrister whose practice is significantly in the area of construction law by providing them with financial incentive and/or assistance during pupillage. Preference will be given to candidates under the age of 40 as at the closing date of application of the year of application under rule 10 below.

### **Eligibility for the scholarship**

5. All applicants are required to attend an interview by the Scholarship Committee in Hong Kong. Those who fail to attend the interview will not be considered for the scholarship.

### **The Award**

6. A recipient of an award shall be called a “Society of Construction Law Hong Kong Scholar”.

7. The Scholarship Committee may decide to not to award a Scholarship in any one year.
8. The award shall include a lump sum payment of such an amount and payable at such time and in such manner as the Council may from time to time determine. The award shall include membership of the Society for a period of one year.
9. The award is conditional upon the Scholar:
  - 1) undertaking and commencing pupillage within such period from the date of the award as may be determined by the Scholarship Committee or within such extended period as the Scholarship Committee may, in its absolute discretion, grant;
  - 2) undertaking and commencing practice as a barrister in Hong Kong for 12 months immediately after completion of pupillage;
  - 3) informing the Scholarship Committee of the date of commencement of his pupillage and full practice and of such other relevant fact and matter as requested by the Scholarship Committee;
  - 4) producing a copy of his logbook as signed by his pupil master;
  - 5) satisfying and/or fulfilling any further condition imposed by the Scholarship Committee as it may, in its absolute discretion, think fit.

### **Application**

10. An application form is available from the Council from 2<sup>nd</sup> January of each year. A completed application form must be submitted to the Council on or before 15<sup>th</sup> February of the same year.

11. The Scholarship Committee may, in its absolute discretion, interview suitable applicants at such time and in such place in Hong Kong as it shall think fit. For the avoidance of doubt, the Scholarship Committee may at its absolute discretion and without giving any reason refuse to interview any applicant.
12. The Scholarship Committee may make any offer at such time and may impose such condition as it may in its absolute discretion think fit without giving any reason.

### **The Scholarship Committee**

13. Subject to Rule 17 below, the Scholarship shall be managed by the "Scholarship Committee".
14. The Scholarship Committee shall consist of no less than three persons. Apart from Members, the Council may from time to time invite and appoint non-Members to serve on the Scholarship Committee.
15. The Scholarship Committee shall decide, in its absolute discretion, on all applications and its decision shall be final.
16. The Scholarship Committee shall provide an annual report to the Council.

### **Administration of the Scholarship Fund**

17. The Council shall administer the Scholarship Fund and shall be at liberty from time to time to delegate such administration or any aspect thereof to a special committee.

**Alteration of Rules**

18. These Rules (including the object) may be altered or revoked and new rules may be made from time to time by the Council after consultation with the Scholarship Committee.

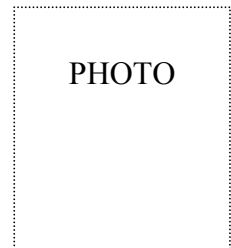
